

Appearance and Materials Release and License Agreement

For good and valuable consideration including the opportunity to potentially appear in Producer's Works, the receipt and sufficiency of which is hereby acknowledged, I hereby grant permission for Exposure LLC dba Exposure Labs, Newsweek Publishing LLC, and their affiliates and respective employees, contractors, agents, and assigns (collectively, "**Producer**") to film, photograph, record, and otherwise capture images, video and sound recordings of me, and to use any recorded images, video, sound recordings, and other materials that I provide to Producer (collectively, the "**Recordings**"); to embody or otherwise utilize the Recordings in audiovisual works (including online media), literary works, pictorial works, and all other forms of media, including without limitation promotion and advertising of the foregoing (the "**Works**"); and to use my name and likeness in connection with the same. I hereby license to Producer the nonexclusive, irrevocable, worldwide, perpetual and unrestricted right to perform, display, distribute, assign, license, modify, edit, create derivative works from, register any intellectual property rights in, and otherwise use and permit others to use the Recordings and the Works for any purpose whatsoever, and to use my name and likeness in connection with the same, in any medium now existing or hereafter developed. I acknowledge and agree that I will not be entitled to payment in connection with any use of the Recordings or Works by the Producer. I waive any so-called "droit moral" or moral rights and any other right to inspect or approve the Recordings or Works or any use of the same, and I hereby release the Producer and its assigns from any liability whatsoever in connection with use of the Recordings or the Works in accordance with this Agreement. I understand that nothing in this Agreement shall obligate the Producer to create or utilize any Recordings or Works.

I hereby represent and warrant that all materials I provide are solely owned by me and that I have all necessary authority to grant all rights provided herein. I hereby release and agree to hold the Producer, its agents and assigns harmless from any and all claims, demands and liabilities arising from my appearance in the Recordings or from any materials that I provide to Producer, including without limitation any claims related to breach of any right of publicity, invasion of privacy, infringement or misappropriation of intellectual property, infliction of emotional distress, libel or defamation.

I understand that Producer may assign the rights and permissions granted herein to third parties, in Producer's sole discretion, and I understand that Producer and its assigns will be relying on and incurring expenses based on this Agreement. I acknowledge that, other than as stated herein, Producer has not said or promised anything to induce me to consent to this Agreement. This Agreement and all rights granted herein are irrevocable and not subject to rescission, revocation or termination. I further understand and agree that under no circumstance shall I be entitled to equitable and/or injunctive relief in connection with this Agreement, the Recordings or the Works. This Agreement may be executed in counterparts and by PDF or electronic signature and shall be governed by the laws of the State of New York.
